**LOCAL GOVERNMENT, SCOTLAND**

**CHANGES IN LOCAL GOVERNMENT AREAS**

**The Monklands and Motherwell Districts (Chapelhall)  
Boundaries Order 1977**

*Made* - - - - - 5th January 1977  
*Laid before Parliament* 17th January 1977  
*Coming into Operation* 1st April 1977

In exercise of the powers conferred on me by section 17(2) of the Local Government (Scotland) Act 1973(a) to give effect to proposals made by the Local Government Boundary Commission for Scotland following a direction given under section 15(2) of the said Act, and of all other powers enabling me in that behalf, I hereby make the following order:—

*Title and commencement*

1. This order may be cited as the Monklands and Motherwell Districts (Chapelhall) Boundaries Order 1977 and shall come into operation on 1st April 1977.

*Interpretation*

2. The Interpretation Act 1889(b) shall apply for the interpretation of this order as it applies for the interpretation of an Act of Parliament.

*Application of Regulations*

3. The Local Government Area Changes (Scotland) Regulations 1977(c) shall apply for the purposes of this order to such extent as may be required to implement the area change effected by article 4 of this order.

*Area change*

4. The area comprising that part of the Motherwell District containing the village of Chapelhall described in the Schedule to this order and delineated and hatched on map 1 annexed and signed as relative to this order shall be transferred to the Monklands District.

## SCHEDULE

Article 4

### TRANSFERRED AREA

The area transferred by this order is bounded as follows:—

commencing on the northern boundary of Motherwell District at NG ref NS 79506126, being a point on the eastern boundary of North and South Road; thence northwestwards along said boundary and continuing northwestwards in a straight line across Glasgow and Edinburgh Road to the eastern boundary of Bellside Road; thence northwestwards along said boundary and continuing northwestwards in a straight line to the point where the eastern boundary of Bellside Road meets the northern boundary of the M8 motorway; thence southwestwards in a straight line to the northern boundary of the A8 (T); thence southwestwards and following the said boundary to the slip road leading to Woodhall Mill Road; thence northwestwards in a straight line across said slip road to the northern boundary of the A8 (T); thence continuing northwestwards along said boundary to NG ref NT 75266232 thence northwards along field boundary to its meeting point with the northern boundary of Motherwell District; thence following the existing district boundary generally northwards and eastwards to the point of commencement;

and the new portion of the boundary between the Motherwell District and the Monklands District is delineated on map 2 annexed and signed as relative to this order.

### EXPLANATORY NOTE

*(This Note is not part of the Order.)*

This Order transfers the village of Chapelhall from the Motherwell District to the Monklands District.

A copy of the map referred to in Article 4 may be inspected at the offices of any of the local authorities referred to in this Order.
