CHANGES IN LOCAL GOVERNMENT AREAS

**The Central and Tayside Regions and Clackmannan District and
Perth and Kinross District (Backhill, Glendevon) Boundaries
Amendment Order 1984**

Whereas under section 17(1) of the Local Government (Scotland) Act 1973(a) the Local Government Boundary Commission for Scotland on 4th July 1983 submitted to me a report on a review conducted under section 14(2) of that Act in which they made proposals for the transfer of a certain area from Clackmannan District in Central Region to Perth and Kinross District in Tayside Region, and in which they also made proposals for changes in electoral arrangements consequential on that change in local government areas;

Now, therefore, in exercise of the powers conferred on me by section 17(2) of the said Act, and of all other powers enabling me in that behalf, I hereby make the following order:—

Title and commencement

1. This order may be cited as the Central and Tayside Regions and Clackmannan District and Perth and Kinross District (Backhill, Glendevon) Boundaries Amendment Order 1984, and shall come into operation on 1st April 1985.

Interpretation

2. In the Schedule to this order—

- (a) any reference to a boundary of a region or district is a reference to a boundary existing immediately before the commencement of this order; and
- (b) any reference to a burn shall, where the context so admits, be construed as a reference to the centre line thereof.

Application of regulations

3. The Local Government Area Changes (Scotland) Regulations 1977(a) shall apply for the purposes of this order to such extent as may be required to implement the area change effected by article 4 of this order.

Area change

4. That part of Central Region and Clackmannan District containing an area at Backhill, Glendevon described in the Schedule to this order and delineated and hatched on the map signed as relative to this order shall be transferred to Tayside Region and Perth and Kinross District.

Consequential changes of electoral arrangements

5. The area described in the Schedule to this order (being the area transferred by article 4 of this order)—

- (a) shall form part of Electoral Division 42 (Tullibardine) of Tayside Region(b) and of District Ward 21 (Orchil) of Perth and Kinross District(c); and
- (b) shall cease to form part of Electoral Division 5 (Devonvale) of Central Region(d) and of District Ward 9 (Harviestoun) of Clackamannan District(e).

SCHEDULE

Articles 4 and 5

Commencing on the northeastern boundary of Central Region and Clackmannan District at a point on the Greenhorn Burn at National Grid reference 89630411 located on OS 1:10000 map (A) NN80SE, date of publication 1978; then generally northward, eastward and southward along the said boundary to the field boundary at National Grid reference 91420353 located on OS 1:10000 map (A) NN90SW, date of publication 1977; then southwestward along the said field boundary to and continuing generally northwestward by field boundaries to the point where they meet the field boundary running southwestward from the reservoir; then southwestward along the said field boundary to the point of commencement.

EXPLANATORY NOTE

(This Note is not part of the Order.)

This order transfers an area of approximately 300 acres at Backhill, Glendevon from Central Region and Clackmannan District to Tayside Region and Perth and Kinross District. The order also makes consequential changes of electoral arrangements.

The area transferred is shown on the map which forms part of this Note.

Copies of the map referred to in article 4 of this order may be inspected at the offices of any of the local authorities referred to in this order.
