CHANGES IN LOCAL GOVERNMENT AREAS

**The East Kilbride and Hamilton Districts (Greenhall Estate,  
Blantyre and Torrance House, East Kilbride) Boundaries  
Amendment Order 1984**

*Made* - - - - - 6th December 1984  
*Laid before Parliament* 7th January 1985  
*Coming into Operation* 1st April 1985

Whereas under section 17(1) of the Local Government (Scotland) Act 1973(a) the Local Government Boundary Commission for Scotland on 21 March 1983 submitted to me a report on a review conducted under section 14(2) of that Act in which they made proposals for the transfer of a certain area from East Kilbride District to Hamilton District, and a certain area from Hamilton District to East Kilbride District, and in which they also made proposals for changes in electoral arrangements consequential on those changes in local government areas;

Now, therefore, in exercise of the powers conferred on me by section 17(2) of the said Act, and of all other powers enabling me in that behalf, I hereby make the following order:—

*Title and commencement*

1. This order may be cited as the East Kilbride and Hamilton Districts (Greenhall Estate, Blantyre and Torrance House, East Kilbride) Boundaries Amendment Order 1984, and shall come into operation on 1st April 1985.

*Interpretation*

2. In the Schedule to this order—

- (a) any reference to a boundary of a district is a reference to a boundary existing immediately before the commencement of this order; and
- (b) any reference to a burn shall, where the context so admits, be construed as a reference to the centre line thereof.

*Application of regulations*

3. The Local Government Area Changes (Scotland) Regulations 1977(a) shall apply for the purposes of this order to such extent as may be required to implement the area changes effected by article 4 of this order.

*Area changes*

4.— (1) That part of East Kilbride District containing an area at Greenhall Estate, Blantyre, described in Part I of the Schedule to this order and delineated and hatched on map number 1 signed as relative to this order shall be transferred to Hamilton District.

(2) That part of Hamilton District containing an area at Torrance House, East Kilbride, described in Part II of the Schedule to this order and delineated and hatched on map number 2 signed as relative to this order shall be transferred to East Kilbride District.

*Consequential changes of electoral arrangements*

5.— (1) The area described in Part I of the Schedule to this order (being the area transferred by article 4(1) of this order)—

- (a) shall form part of Electoral Division 66 (Hamilton North) of Strathclyde Region(b) and of District Ward 18 (High Blantyre) of Hamilton District(c); and
- (b) shall cease to form part of Electoral Division 67 (Calderwood/St Leonard's) of Strathclyde Region and of District Ward 1 (Maxwellton) of East Kilbride District(d).

(2) The area described in Part II of the Schedule to this order (being the area transferred by article 4(2) of this order)—

- (a) shall form part of Electoral Division 67 (Calderwood/St Leonard's) of Strathclyde Region and of District Ward 5 (Calderglen) of East Kilbride District; and
- (b) shall cease to form part of Electoral Division 66 (Hamilton North) of Strathclyde Region and of District Ward 18 (High Blantyre) of Hamilton District.

## SCHEDULE

Articles 4 and 5

### PART I

That area bounded by a line commencing at a point where East Kilbride District boundary is opposite the northeastern boundary of parcel No. 6766 as shown on OS 1:2500 microfilm NS 6656 Edition A, date of publication 1978; then northwestward to and along the said boundary to and generally eastward along the southern boundary of parcel No. 9088 to the northern boundary of parcel No. 1085 as shown on OS 1:2500 microfilm NS 6756 Edition A, date of publication 1979; then generally eastward along the said boundary and the southern boundary of parcel No. 0006 to Cocks Burn; then generally southeastward along the said burn to East Kilbride District boundary; then generally westward along the said boundary to the point of commencement.

### PART II

That area bounded by a line commencing at a point where Hamilton District boundary is opposite the northern boundary of parcel No. 6783 as shown on OS 1:2500 microfilm NS 6552 Edition B, date of publication 1978; then eastward to and along the said boundary and eastward and generally southwestward along the northern and eastern boundaries of parcel No. 8869 to and southward along the western boundary of parcel No. 0026 to the southern boundary of the said parcel; then westward along the top of the cliff feature for approximately 60 yards to and southwestward along the detail and in prolongation thereof to Hamilton District boundary; then northwestward and generally northward along the said boundary to the point of commencement.

## EXPLANATORY NOTE

*(This Note is not part of the Order.)*

This order transfers an area of approximately 13 acres at Greenhall Estate, Blantyre from East Kilbride District to Hamilton District and an area of approximately 38 acres at Torrance House, East Kilbride from Hamilton District to East Kilbride District. The order also makes consequential changes of electoral arrangements.

The areas transferred are shown on the maps which form part of this Note.

Copies of the maps referred to in article 4 of this order may be inspected at the offices of any of the local authorities referred to in this order.
