#### CHANGES IN LOCAL GOVERNMENT AREAS

# The City of Edinburgh District and Midlothian District (Danderhall) Boundaries Amendment Order 1985

Made - - - - - 25th September 1985
Laid before Parliament 17th October 1985
Coming into Operation 1st April 1986

In exercise of the powers conferred on me by section 17(2) of the Local Government (Scotland) Act 1973(a) to give effect to proposals made by the Local Government Boundary Commission for Scotland under section 14(2) of the Act, and of all other powers enabling me in that behalf, I hereby make the following order:—

#### Title and commencement

1. This order may be cited as the City of Edinburgh District and Midlothian District (Danderhall) Boundaries Amendment Order 1985, and shall come into operation on 1st April 1986.

#### Interpretation

2. In the Schedule to this order any reference to a boundary of a district is a reference to a boundary existing immediately before the commencement of this order.

#### Application of regulations

3. The Local Government Area Changes (Scotland) Regulations 1977(b) shall apply for the purpose of this order to such extent as may be required to implement the area changes effected by article 4 of this order.

#### Area changes

4.— (1) Those parts of the City of Edinburgh District containing areas being the Area A and the Area B described in Part I of the Schedule to this order and delineated, hatched and marked "Area A" and "Area B" on the map signed as relative to this order shall be transferred to Midlothian District.

(2) That part of Midlothian District containing an area being the Area C described in Part II of the Schedule to this order and delineated, hatched and marked "Area C" on the map signed as relative to this order shall be transferred to the City of Edinburgh District.

## Consequential changes of electoral arrangements

- 5.— (1) Areas A and B described in Part I of the Schedule to this order (being the areas transferred by article 4(1) of this order)—
  - (a) shall form part of Electoral Division 43 (Dalkeith) of Lothian Region(a) and of District Ward 10 (Dalkeith/Newton) of Midlothian District(b); and
  - (b) shall cease to form part of Electoral Division 38 (Inch/Gilmerton) of Lothian Region and of District Ward 60 (Gilmerton) of the City of Edinburgh District(c).
- (2) Area C described in Part II of the Schedule to this order (being the area transferred by article 4(2) of this order)—
  - (a) shall form part of Electoral Division 38 (Inch/Gilmerton) of Lothian Region and of District Ward 60 (Gilmerton) of the City of Edinburgh District; and
  - (b) shall cease to form part of Electoral Division 43 (Dalkeith) of Lothian Region and of District Ward 10 (Dalkeith/Newton) of Midlothian District.

#### PART I

#### AREA A

Commencing on the eastern boundary of the City of Edinburgh District at the north-eastern corner of N.E. Lodge, No. 640 Old Dalkeith Road; then southwestward and southeastward along the side and rear curtilages of the said Lodge and continuing in a straight line along the rear curtilage of S.E. Lodge, No. 642 Old Dalkeith Road, to the south-western corner of the said curtilage; then northeastward along the side curtilage of the said Lodge to the western side of Old Dalkeith Road; then southeastward along the side of the said road to and southwestward along the northern curtilage of No. 674 Old Dalkeith Road to the rear curtilage of the said property; then generally southeastward along the rear curtilages of Nos. 674 to 684 Old Dalkeith Road to the eastern boundary of the City of Edinburgh District; then northeastward and northwestward along the said District boundary to the point of commencement.

#### AREA B

Commencing on the southern boundary of the City of Edinburgh District at NG ref NT 3145867846, as shown on O.S. 1:2500 microfilm NT 3167(B), date of publication 1952; then northeastward from the said point in a straight line to and along the southeastern boundary of Parcel No. 4193, as shown on O.S. 1:2500 microfilm NT 3167(B), date of publication 1952, and continuing northeastward along the northeastern boundary of Parcel No. 4400, as shown on O.S. 1:2500 microfilm NT 3168 (C\*), date of publication 1967, to the eastern boundary of the City of Edinburgh District; then generally southeastward, southwestward and westward along the said District boundary to the point of commencement.

#### PART II

#### AREA C

Commencing on the western boundary of Midlothian District at the point where the southern curtilage of No. 684 Old Dalkeith Road meets the western side of Old Dalkeith Road; then generally southeastward along the side of the said road to the northwestern boundary of Parcel No. 6306, as shown on O.S. 1:2500 microfilm NT 3168 (C\*), date of publication 1967; then southwestward along the said parcel boundary to and generally northwestward and northeastward along the western boundary of Midlothian District to the point of commencement.


### EXPLANATORY NOTE

(This Note is not part of the Order.)

This order transfers areas of approximately 15 acres at Danderhall from the City of Edinburgh District to Midlothian District and an area of about 31 acres from Midlothian District to the City of Edinburgh District. The order also makes consequential changes of electoral arrangements.

The areas transferred are shown on the map which forms part of this Note.
