The Local Government Boundary Commission for Scotland today publishes its provisional proposals for the realignment of the administrative area boundary between Glasgow City and North Lanarkshire council areas at Cardowan, near Stepps. The public's views are being sought on the proposals and comments can be made at our consultation hub https://consult.scotland.gov.uk/local-boundary-commission-for-scotland/boundary-review-at-cardowan or by email or writing and should be submitted to the Commission by 6 September 2017.

The boundary review was initiated following a large number of requests from local residents in Glasgow City Council area who argued that they had stronger ties with North Lanarkshire council area and felt they were disadvantaged by being in a different council area from neighbours in the same development.

The Commission is proposing that the boundary be realigned with the southernmost edge of the newly completed development. If adopted, this would result in the transfer of approximately 150 homes from Glasgow City Council area to North Lanarkshire Council area.

Responses to the review from Glasgow City Council and North Lanarkshire Council can be viewed on our website. Both Councils raised concerns about any change to the council area boundary at Cardowan.

The Commission's Secretary, Ms Isabel Drummond-Murray said: "We are particularly keen to hear from those residents and electors affected by the proposed changes, but would welcome any interested parties' views, whether in favour of the proposals or not."

Following the public consultation, the Local Government Boundary Commission for Scotland will consider all the representations received. The Commission expects to report its final recommendations to Scottish Ministers later in 2017 or early 2018.
